**3/23 GUIDANCE FOR LINK ADVISORS ON RELIGIOUS EDUCATION**

Prior to the meeting members had received a copy of 'Primary Subject Information : Religious Education 2022/2023'.

The document had been written to support Derbyshire link advisers to carry out a curriculum review of religious education and provide some background information where the link adviser was not a subject specialist

#### **4/23 NEW GUIDANCE - EQUALITY ACT 2010**

Prior to the meeting members had been circulated a link to the new Guidance on the Equality Act 2010 and had also received a copy of the presentation that had formed part of training course for governors provided by the Education Improvement Service on “Equality Act 2010: The new Ofsted Framework and its expectations”

The course explored, the:

- broader responsibilities on all public bodies including schools;
- the concept of due regard;
- the need for schools to publish on their website their equality objectives

It was hoped that this document would provide a valuable insight for SACRE members into the Equality Act and Ofsted’s expectations, and Steve Ford agreed to circulate the Guidance more widely. The next training for Governors was due to be delivered in April 2023
