30/20 ALL-WEATHER PITCH AT HIGHFIELDS SCHOOL, MATLOCK

Highfields School, Matlock has developed a scheme for an all-weather pitch and associated facilities, at a total cost of £873,351.25. The Authority secured £400,000 in Section 106 funding from a housing development at Bentley Bridge (reference 15/00861/FUL) which was index linked and a total of £442,352.94 has now been received. The School was making a contribution of £20,000 and was submitting an application for £413,999.25 Football Foundation funding The Authority as landowner of the school would be a party to the Football Foundation application.

The Authority will be a party to the application and have a shared responsibility for on-going maintenance and repair. However as school funding was

delegated to the school, the Authority was not in a position to commit to that ongoing revenue responsibility. If the Football Foundation Grant was approved, the Authority would enter into an indemnity agreement with the school to pass those revenue responsibilities to the school. The Section 106 funding would also be covered by a legal agreement to ensure that it is used in line with the agreement.

RESOLVED that (1) the allocation of £442,352.94 Section 106 funding towards the all-weather pitch and associated facilities at Highfields School, subject to the successful granting of Football Foundation funding, be approved; and

(2) officers ensure that as per the financial considerations contained in the report there is no ongoing liability for maintenance to the Local Authority and the school is fully aware of their responsibility for ongoing revenue and maintenance costs.

Report of the Executive Director for Children's Services ESSENTIAL HAMPERS FOR FOSTER CARERS

1. Purpose of the Report

To provide an update to the Cabinet Member regarding the recent project to supply essentials hampers to DCC Foster Carers. The report highlights some of the cross council working that took place, as well as feedback from DCC Foster Carers.

2. Information and Analysis

Background

Due to Covid 19 pandemic there are more pressures on DDC foster carers. DCC wanted to recognise the contribution foster carers are making, by providing a good will gesture. It is hoped this project will maintain good relations amongst the DCC foster carers.

The hampers were produced by the school catering service and included donations from community partners. The hampers included:

- Essential Food Hamper value up to £30
- Delivered in cardboard box 65x45x45cm
- Easter Egg for each child in placement
- Cuddly teddy bear per hamper
- Ream of Paper
- Thank you note from Councillor Alex Dale

This project was an excellent example of cross-departmental working in the council. Key areas that exemplified a "can do" attitude are:

Catering Services

Catering services provided an example hamper, ordered the materials and arranged the staff to pack the hampers, ready for collection by taxi's. Collected the printing from Business Services, and linked with external partners delivering other parts of the hamper.

ETE

As a result of Covid19, taxi companies contracted to DCC for school transport, were not being utilised. Staff members spoke to operators, and planned the logistics of 219 individual drops, providing the lists to catering so they could organise the hampers into drops and provided support around Covid19 packing processes.

Fostering Team

Input into the data lists to ensure all Foster families details were correct and helped to define the items that would be best received by Foster Families.

Commissioning, Communities and Policy

Provided template and support with Risk Assessment, specifically around Covid19 and distribution of hampers.

External Partners

We also had input from community partners, namely Operation Orphan and Excel Printing who both contributed to the contents of the hamper (see above)

Enterprising Council

This programme is in keeping with the council's priorities around value for money and working with people to increase their resilience and reduce demand on services. It also typifies a one Council approach.

Outputs and Outcomes

Hampers were packed and prepared by Catering on Thus 16th April and delivered to Foster Families Friday 17th April.

The feedback has been overwhelming. Over 40 comments from foster carers have been received. A selection is shown in appendix 1.

3. Financial Considerations

Having received corporate and third sector donations, it was possible to minimise costs and brought the total cost down to £6570.

4. Legal Considerations

The Council has powers in accordance with S1-6 of the Localism Act 2011 to do that which will be to the 'benefit of the authority, its area or persons

resident or present in its area.' The proposed benefit of this action is to support the role of foster carers in providing an essential service.

5. Social Value Considerations

This initiative has made use of local suppliers of council services who are currently impacted by the Covid19 crises. Furthermore, the Council has made good use of resources by re-directing services that are not currently able to be delivered to this project (ETE – School Transport Services / School Catering Provision)

The project is also supporting vulnerable children in Foster Care, as well as supporting the Foster Carers with items that may be difficult to acquire.

6. Human Resources Considerations

- Use of catering staff / staff allocated to different areas.
- Cross departmental working

7. Executive Director's Recommendations

That Cabinet Member notes the positive impact the project has had on relations with DCC foster carers, the feedback received (appendix 1) and the example of cross council working.
