(30MPH, 40MPH AND 50MPH SPEED LIMIT) ORDER 2021

Derbyshire County Council hereby gives notice that it proposes to make an Order under the Road Traffic Regulation Act 1984, the effect of which will be, in respects of roads in the Districts of Derbyshire Dales, North-East Derbyshire, Bolsover District and the Borough of Chesterfield. The affect of which will be that no person shall drive any motor vehicle at speeds exceeding 30, 40 and 50 miles per hour on the following lengths of road:

PROPOSED 30MPH SPEED LIMIT

A632 (Lime Tree Road and Chesterfield Road) in Matlock

from its junction with the A615 at Matlock Green in a north-easterly direction to a point 298 metres north-east of its junction with Quarry Lane Quarry Lane.

A632 (Matlock Road and Walton Road) in Chesterfield

from a point 496 metres south-west of its junction with Foljambe Avenue in an easterly then northerly direction to its junction with the A619 Chatsworth Road

PROPOSED 40MPH SPEED LIMIT

A632 (Chesterfield Road) in Matlock

from a point 298 metres north-east of its junction with Quarry Lane in a north-easterly direction to a point 848 metres north-east of the same junction

A632 (Matlock Road) in Chesterfield and the Parish of Holymoorside and Walton

from a point 127 metres north-east of its junction with Stoneycroft Lane in a north-easterly direction to a point 496 metres south-west of its junction with Foljambe Avenue

PROPOSED 50MPH SPEED LIMIT

A632 (Chesterfield Road, Slack Hill and Amber Lane) in Matlock and the Parish of Ashover

from a point 848 metres north-east of its junction with Quarry Lane in a north-easterly direction to a point 201 metres south of its junction with the B6036 Ashover Road **A632 (Matlock Road) in the Parish of Ashover**

from a point 273 metres north-east of its junction with the B6036 Ashover Road in a northerly direction to a point 247 metres south of its junction with Highashes Lane

A632 (Matlock Road) in the Parish of Wingerworth and Holymoorside and Walton

from a point 353 metres north of its junction with Belland Lane in a north-easterly direction to a point 127 metres north-east of its junction with Stoneycroft Lane


