Highways Technical Policy, Plans and Strategies – New and Update Approvals

- 3. Purpose
- 3.1 To summarise those Highway Technical Policy, Plans and Strategies updates and approvals that have occurred since the Cabinet Report on 26 July 2018 and request that all highways technical policy, plans and strategies approvals and updates be delegated to the Director Highways from the Executive Director Place and the Cabinet Member for Highway Assets and Transport.

4. Information and Analysis

4.1 On 26 July 2018, it was agreed that all updates to the plans and strategies and any new policy, strategies and plans should be approved by the Cabinet Member – Highways, Transport and Infrastructure in conjunction with the Executive Director - Place (Economy, Transport and Environment Department at the time) (Minute No. 186/18 refers). The Cabinet Member - Highways, Transport and Infrastructure (at the

- time) requested that these documents should be approved by the Service Director - Highways due to the high number of updates to the suite of documents being completed. This was a verbal request.
- 4.2 Since then, the documents below have been approved by either the Service Director Highways or Acting Service Director- Highways. It is recommended that all approvals relating to the suite of policies should continue to be completed by the Director Highways. In certain circumstances where a broader level of engagement and scrutiny is required, the Executive Director Place and the Cabinet Member Highways Assets and Transport will be consulted to agree the necessary action and approvals process.
