Health and Wellbeing Round Up Report

1. Purpose

1.1 To provide the Board with a round-up of key progress in relation to Health and Wellbeing issues and projects not covered elsewhere on the agenda.

2. Round-Up

2.1 **Levelling Up White Paper**

The Levelling Up White Paper is a flagship document that sets out how the government will spread opportunity more equally across the UK. It comprises a programme of systems change, including 12 UK-wide missions to anchor the agenda to 2030, alongside specific policy interventions that build on the 2021 Spending Review to deliver change now.

2.2 Tobacco control and stop smoking services in local authorities in England 2021

The Action on Smoking and Health have produced a <u>report</u> highlighting their findings from the eighth annual ASH/CRUK survey of tobacco control leads in local authorities in England. It explores both the ongoing impact of the Covid-19 pandemic and current efforts to reduce the inequalities that define the smoking epidemic in England.

2.3 Inequality and the Covid crisis in the United Kingdom

The Institute for Fiscal Studies has published a <u>review report</u> of the effects on the Covid-19 pandemic on inequalities in education, the labour market, household living standards, mental health and wealth in the UK.

2.4 Overcoming health inequalities in 'left behind' neighbourhoods

The All-Party Parliamentary Groups have published a <u>report</u> titled overcoming health inequalities in 'left behind' neighbourhoods. The report covers the areas identified as 'left behind' have among the worst health outcomes in England, with growing disparities between them and the rest of the county.

2.5 Briefing on the Health and Care Bill

The Kings Fund has published a <u>briefing</u> on the Health and Care Bill which, as the Bill reaches Committee stage in the House of Lords, focuses on Parts 1 and 6 of the Bill, which deal with the NHS and its relationship to other parts of the system plus changes to the cap on social care costs.

2.6 The White Paper on Reforming the Mental Health Act

The House of Commons Library has published a <u>briefing</u> which discusses proposals in the Government's <u>White Paper</u> on Reforming the Mental Health Act 1983.

2.7 How does the health and care system hear from people and communities?

The Kings Fund have published and <u>explainer</u> which sets out how people's lived experience is a powerful tool to improve existing services and identify new ways to meet their needs. The explainer explores the different methods that the NHS and local government can use to learn from people and communities.

2.8 The barriers preventing women accessing housing and homelessness support, and the women-centred approach needed to overcome them

Shelter has published a <u>report</u> looking into the barriers preventing women from accessing housing and homelessness support and the women-centred approach needed to overcome them.

2.9 Living Safely and Fairly with Covid-19

The Association of Directors of Public Health (UK) has published an explainer for living safely and fairly with Covid-19.

2.10 **Derbyshire Safeguarding Adults Board Annual Report**

The Derbyshire Safeguarding Adults Board has published its <u>annual</u> report and two page summary for 2020/21.

2.11 **Social Care 360**

The Kings Fund has published their latest <u>360 review</u> which outlines and analyses 12 key trends in adult social care in England over recent years, encompassing the first and second waves of the Covid-19 pandemic. Using a variety of publicly available data, it provides a uniquely rounded – '360 degree' – view of the sector.

2.12 The rollout of the Covid-19 vaccination programme in England

The National Audit Office have published a <u>report</u> around the rollout of the Covid-19 vaccination programme in England. According to this report, the Covid-19 vaccination programme met stretching and unprecedented targets, helping to save lives and reduce serious illness and hospitalisation. However, it concludes that there are risks to be managed as the programme continues to evolve in response to the Covid-19 pandemic and to new clinical advice and evidence about vaccines. The report covers the funding and costs of the programme, supply of vaccines, access to the vaccines as well as the attempts to address inequalities in the uptake of the vaccines. The report concludes that the programme has provided value for money to date.

3. Notification of Pharmacy Applications

Consultation will begin on the draft document in June 2022 and the final assessment will be bought to the Health and Wellbeing Board in September 2022.
