# **Covid-19 Community Fund Annual update** (Cabinet Member for Health and Communities)

- 3. Purpose
- 3.1 To provide an update on organisations supported through the Public Health Covid-19 Community Fund for 2022-23.
- 3.2 To seek approval to further extend the Covid-19 Community Fund to March 2024 to provide financial support to community and voluntary sector organisations across Derbyshire to promote ongoing efforts to mitigate the ongoing impact caused by Covid-19

# 4. Information and Analysis

4.1 On 26 July 2022, the Cabinet Member for Health and Communities approved the continuation of a Public Health COVID-19 Community Fund to provide ongoing support to organisations impacted by the pandemic. The fund supports community and voluntary sector

organisations to continue their support to communities most affected by Covid-19 and to mitigate the risk of further infection. Applications must be in line with the 'Living with Covid-19' guidance. Constituted organisations and groups can apply for up to £2,000, and non-constituted organisations and groups can receive up to a maximum of £250.

- 4.2 The Public Health Covid-19 Community Fund is funded from the Contain Outbreak Management Fund, a specific grant from central Government to enable local authorities to continue to support ongoing outbreak management activity in relation to Covid-19. For this reason, all applications need to be linked to the grant conditions. This includes being able to meet at least one of the below criteria:
  - support to increase COVID-19 vaccination uptake
  - protect people most vulnerable to COVID-19
  - increase mental health and wellbeing and support individual and community resilience
  - promote safer behaviours to reduce future risk of infection
- 4.3 Authority for approval of applications was delegated by the Cabinet Member to the Director of Public Health, with quarterly update reports in respect of organisations funded to Cabinet Member meetings. This is the annual update covering all organisations who have received funding from 1 September 2022
- 4.4 The applications, detailed below, have been reviewed and approved for funding. Funding decisions are made by a panel comprising of a Public Health Lead and members of the Health Protection Team, before ratification by the Director of Public Health. Any organisations not meeting the criteria for funding, where appropriate, are signposted to other funding streams. This is one-off, non-recurrent funding. There is no ongoing commitment once funding has been utilised. The following organisations, have been approved for funding:

4.5 It is proposed a further £100,000 is allocated to the fund from the Contain Outbreak Management Fund for 2023-24, so Public Health can

continue to support local organisations to mitigate the impacts of the COVID-19 within local communities. This will enable community groups to have a robust approach in place to prevent the spread of COVID-19 and support recovery and address health inequalities arising from the pandemic.

## 5. Alternative Options Considered

5.1 Not supporting the approval of the Covid-19 Community Fund grants as recommended, would result in local organisations and communities being less resilient and not being able to sufficiently support those who have been more adversely impacted by the pandemic. This would result in a decrease in the ability of communities to practice safer behaviours in relation to infections, less support for mental health and wellbeing and a decrease in support from those more vulnerable to the effects of COVID-19.

# 9. Recommendation(s)

- d) Agree to receive quarterly updates on the activity approved by the fund

- 10.1 To allow the Council to continue to provide financial support to community and voluntary sector organisations across Derbyshire to provide support to those most impacted by the Covid-19 pandemic, and mitigate the future risk of infection
- 10.2 The Cabinet Member is required to review the allocations to the Covid-19 Fund to date.
- 10.3 Continuing to provide delegated authority to the Director of Public

Health for grant allocations will ensure that the grants are issued in a timely manner to groups and organisations.

## <u>Implications</u>

#### **Financial**

1.1 The overall value of the Public Health Covid-19 Community Fund is £0.100m and to date £49,139 has been awarded to Derbyshire organisations. Funding has been met from the Contain Outbreak Management Fund for the grants summarised in this report and £100,000 will be made available for 2023/24.

## Legal

2.1 The Council's Financial Regulations allow grants of up to £0.100m to organisations to be approved by Cabinet Member. The Council's Constitution allows for Cabinet Members to delegate authority to officers to undertake the powers afforded to them by the Constitution. The Council's standard grant agreement shall be used to set out the terms and conditions for which the grants are made, which provides for clawback of funding in certain circumstances and shall also provide that the Council is not liable for any employment liabilities

#### **Human Resources**

3.1 The funding will enable local providers to deliver projects and services. Derbyshire County Council accepts no employment or future redundancy liability, with all employment and related matters to be managed by the providers.
