Fire Mitigation Programme 2023-24

(Cabinet Member for Corporate Services & Budget)

- 1. Divisions Affected
- 1.1 County Wide
- 2. Key Decision
- 2.1 This is a key decision because it is likely to result in the Council incurring expenditure which is, or savings which are significant having regard to the budget for the service or function concerned (this is currently defined as £500,000)
- 3. Purpose
- 3.1 Approval is sought for the allocation and procurement of the Fire Mitigation Programme (FMP) of works within the Derbyshire County Council's property portfolio.
- 4. Information and Analysis
- 4.1 Further to the recent cabinet meeting approving the Capital Programme Approvals, Treasury Management and Capital Strategies report which included the approval of the Fire Mitigation Programme for 2023-2024 on 02 February 2023. This report seeks approval to allocate projects to

the FMP budget for 2023-2024. The initial approval on the 02 February 2023 was for £0.5m.

The FMP is formulated from a continued programme of Technical Fire Risk Assessments undertaken by Corporate Services & Transformation Fire Risk Assessors based on The Regulatory Reform (Fire Safety) Order 2005 Legislation. Properties are categorised based on their usage and prioritised accordingly for FMP identified works.

The programme is asset challenged to ensure that the prioritisation is also aligned to the Asset Management Strategy and the asset rationalisation programme and to reduce abortive work.

The FMP is determined on an annual basis and the proposed allocation for the 2023-2024 FMP comprises 18 projects with a total estimated value of £0.5m

Details of the proposed FMP projects are contained in Appendix 2. Although each project will commence during the current financial year, not all works on the various sites will be completed during the current financial year. Any changes to proposed budget allocations or to the FMP will be approved in accordance with the Council's Financial Regulations.

6. Alternative Options Considered

- 6.1 Not to undertake the FMP would result in potential loss of building stock as the result of spread of fires.
- 6.2 Not to undertake FMP would leave staff and members of the public at risk in the event of fire within the Council's building portfolio.

10. Recommendation(s)

That Cabinet:

- a) Approves the Fire Mitigation Programme 2023-2024.
- b) Approves all goods, works and services required to undertake the identified projects within the Fire Mitigation Programme 2023-2024 which will be procured and awarded in accordance with the Council's Financial Regulations.
- c) Approves the procurement of the projects identified in appendix 2 which are included in the Councils forward plan in-line with the Council's Financial Regulations.
- d) Notes that some contracts award will be approved in accordance with the Councils Departmental Scheme of Delegation.

11. Reasons for Recommendation(s)

- 11.1 Failure to undertake fire mitigation works would lead to non-compliant building stock and present a risk to staff and public using the buildings as identified with in Regulatory Reform (Fire Safety) Order 2005.
- 11.2 These works will protect lives and building stock assets in the event of fire along with preventing finical loss and loss of service through fire.
