Stewardship Report

1. Purpose

1.1 To provide the Pensions & Investments Committee with an overview of the stewardship activity carried out by Legal & General Investment Management (LGIM), one of Derbyshire Pension Fund's (the Fund) external investment managers, in the guarter ended 31 December 2023.

2. Information and Analysis

2.1 **Stewardship Activity**

This report attaches the Q4 2023 LGIM ESG Impact Report (Appendix 2) to ensure that the Pensions and Investments Committee is aware of LGIM's stewardship activity. LGIM currently manages around £1.9bn of assets on behalf of the Fund through passive products covering: UK Equities; Japanese Equities; Emerging Market Equities; and Global Sustainable Equities. The report provides an overview of LGIM's current key stewardship themes and voting and engagement activity over the quarter to 31 December 2023.

The quarterly Stewardship Report to the Pensions & Investments Committee also generally includes a quarterly stewardship report from LGPS Central Limited (LGPSC), the Fund's pooling company. However, in line with a prior year change to the LGPSC stewardship reporting cycle, a Q3 2023-24 LGPSC Stewardship Report has not been prepared and the stewardship activity for the quarter will be covered in LGPSC's Annual Stewardship

Report for the year to 31 March 2024. This is scheduled for release in May or June 2024 and will be reported to Committee in due course.
