## 02/24 MINUTES

### 03/24 REVIEW OF THE CODE OF CONDUCT FOR ELECTED MEMBERS

Principal Solicitor E Wild introduced a report, outlining that a review of the current Code of Conduct for Members and procedure for considering complaints that Members have breached the Code of Conduct had been undertaken by the Working Group nominated by this Committee and the purpose of the report was to inform the Committee of the outcome of the review and make recommendations for amendments.

#### **RESOLVED** to

- 1) support the proposal to include the additional sanction and approve the revised Procedure for Considering Complaints that Members have breached the Code of Conduct at Appendix 2 to the report;
- 2) agree the proposed amendment regarding presentation outlined at paragraph 2.9 of the report and included in the revised Code of Conduct at Appendix 3 to the report and refer these amendments to Council for approval and inclusion within the Constitution;
- 3) agree that there should be a review of the procedure for considering

complaints against Members and the Code of Conduct for Members once every two years with the next review being scheduled for October 2025; and

4) request officers to implement further training in respect of the requirements for declaring interests.
